## Q: Can you get a DUI on a bicycle?

A: It is possible to get a DUI on a bicycle. A lot of the times people would think that if they go to the bar or out with friends and they ride their bike, that they can't get in trouble, even if they're intoxicated and driving home, and that's simply not true. Anytime you ride a bicycle on a public roadway, you are subject to the traffic laws in the state of Ohio. One of those traffic laws is, in fact, you can't operate that bicycle while under the influence of alcohol. With Halloween coming up, don't let your spooky season turn sour and be sure to plan for a safe, sober ride home.

## **Protect Yourself as a Pedestrian**

Pedestrian accidents are usually in the category of 'serious'. Anytime a pedestrian is hit by a car, there's the potential for injury or death. As Halloween is approaching, we need to be thinking about pedestrian safety and also the laws that cover right-of-way.

From a safety perspective, if a sidewalk isn't available, it's always best to walk toward traffic as opposed to with traffic. This allows you to not only hear cars as they are coming towards you, but also to see them. And remember, just because you can see them that does not mean they can see you. Always wear bright colored clothing, preferably reflective. If it's before dawn or after dusk, you should also wear something that illuminates – like a safety vest, flashing light, or headlamp.

Ohio's pedestrian laws can be found in chapter 4511 of the Ohio Revised Code. They require the use of the sidewalk where available and control who has the right-of-way. It's not as simple as saying that pedestrians always have the right-of-way, because they don't. The law prohibits pedestrians from walking on the freeway and it requires them to obey all traffic control devices (like walk signals and signs). It requires cars to yield to all pedestrians on sidewalks but requires all pedestrians to yield to traffic when crossing the street outside of a crosswalk.

Common sense goes a long way when it comes to pedestrian safety. Regardless of who has the right-of-way, any accident that involves getting hit by a car is serious. Please be safe this Halloween!
